# **Weekly tax table with no and half Medicare levy**

Including Medicare levy adjustment to half levy – table



**FOR PAYMENTS MADE ON  
OR AFTER 1 JULY 2007.**



This document is a withholding schedule made by the Commissioner of Taxation in accordance with sections 15–25 and 15–30 of Schedule 1 to the *Taxation Administration Act 1953*. It applies to withholding payments covered by Subdivisions 12–B (except sections 12–50 and 12–55) and 12–D of Schedule 1.

## WHO SHOULD USE THIS TABLE?

Use this table if you make payments to a payee who is a prescribed person entitled to a full or half levy exemption from the Medicare levy. Prescribed persons include members of the defence force and certain recipients of Repatriation and Social Security pensions and benefits.

This table should be used if you make the following payments to these payees on a weekly basis:

- salary, wages, allowances and leave loading paid to employees
- director's fees
- salary and allowances paid to office holders (including Members of Parliament, statutory office holders, defence force members and police officers)
- payments to labour hire workers
- payments to religious practitioners
- Commonwealth education or training payments, and
- compensation, sickness or accident payments that are calculated at a periodical rate and made because a person is unable to work (unless the payment is made under an insurance policy to the policy owner).

If you make payments to these payees on a fortnightly, monthly or quarterly basis, you will need to convert their payments into weekly earnings. See 'Fortnightly, monthly or quarterly withholding amounts' on page 3.

Some payees (shearers, fruit and vegetable harvesters, foreign residents, performing artists and those engaged on a daily basis) may be subject to different withholding arrangements. There are also special arrangements for withholding from payments made under voluntary agreements. For this table to apply, the payee must have completed:

- a valid *Tax file number declaration* (NAT 3092) claiming the tax-free threshold, and
- a *Medicare levy variation declaration* (NAT 0929) claiming a full or half levy exemption from their Medicare levy.

## USING FORMULAS

Withholding amounts shown in this table can be expressed in a mathematical form.

If you have developed your own payroll software package, you will need to use the *PAYG withholding – Statement of formulas for calculating amounts to be withheld* (NAT 1004). A copy of this schedule is available from [www.ato.gov.au](http://www.ato.gov.au)

## TAX FILE NUMBER (TFN) DECLARATIONS

The amount to be withheld from payments you make to your payees is primarily determined by the answers given by the payee on a *Tax file number declaration*. A *Tax file number declaration* applies to payments made after the declaration is provided to you. A later declaration provided by a payee overrides an earlier declaration.

If a payee does not give you a valid *Tax file number declaration* within **14 days** of starting a payer/payee relationship, you must fill in a *Tax file number declaration* with all available details of the payee and send it to the Tax Office.

If you have *Employment declarations* that were valid at 30 June 2000, they will continue to be valid under PAYG.

## NO TFN PROVIDED

If you make a payment to a payee and the payee **has not**:

- quoted their TFN
- claimed an exemption from quoting, or
- advised that they have applied for a TFN or made an enquiry with the Tax Office

on their *Tax file number declaration*, you must withhold 46.5% of the payment, ignoring any cents.

If a payee states at question 1 of the *Tax file number declaration* that they have lodged a *Tax file number application or enquiry* with the Tax Office, the payee has **28 days** to give you their TFN.

If the payee has not given you their TFN at the end of this time, you must withhold 46.5% from the total amount of all payments made to the payee, ignoring any cents, unless the Tax Office tells you not to.

- ❗ Do not allow any family tax benefit (FTB), tax offsets or Medicare levy adjustment. Do not add amounts for HELP or SFSS.

## FULL EXEMPTION FROM MEDICARE LEVY

To obtain a full exemption from the Medicare levy, the payee must have completed section A of the *Medicare levy variation declaration* and answered 'Yes' to both question 5, 'Do you qualify for a Medicare levy exemption?' and question 6, 'Do you want to claim a full exemption from the Medicare levy?'.

## HALF LEVY EXEMPTION FROM MEDICARE LEVY

To obtain a half levy exemption from the Medicare levy, the payee must have completed Section A of the *Medicare levy variation declaration* and answered 'Yes' to both question 5, 'Do you qualify for a Medicare levy exemption?' and question 7, 'Do you want to claim a half levy exemption from the Medicare levy?'.

## MEDICARE LEVY ADJUSTMENTS

To claim the Medicare levy adjustment available to some low income earners with dependants, a payee must lodge a *Medicare levy variation declaration* along with their *Tax file number declaration*.

If a payee has claimed a half levy exemption from the Medicare levy and has also answered 'Yes' to questions 10 and 12 on the *Medicare levy variation declaration*, they may be entitled to a Medicare levy adjustment if their weekly earnings are \$537 or more. For instructions on working out the Medicare levy adjustment to half levy, refer to page 12 of this schedule.

## WITHHOLDING DECLARATIONS

A payee may use the *Withholding declaration* to advise their entitlement to the family tax benefit (FTB) or a tax offset, which they choose to claim through reduced withholding. See page 3 for more information.

Withholding declarations can also be used by payees to advise you of changes to their situation since providing a valid *Tax file number declaration*, which may affect the amount to be withheld from their payments.

Changes which may affect the amount to be withheld include:

- becoming or ceasing to be an Australian resident for tax purposes
- claiming or discontinuing a claim for the tax-free threshold
- advising a HELP or SFSS debt or changes to them
- entitlement to a senior Australians tax offset, and
- upward variation to increase the rate or amount to be withheld.

A *Withholding declaration* has effect from the first payment you make after the payee has provided the declaration. A later declaration provided by a payee overrides an earlier declaration.

- ❗ A valid *Tax file number declaration* (or *Employment declaration*) must be in place before a payee can authorise you to vary their withholding by providing a *Withholding declaration*.

## FORTNIGHTLY, MONTHLY OR QUARTERLY WITHHOLDING AMOUNTS

First calculate the weekly equivalent of fortnightly, monthly or quarterly earnings. If paid:

- fortnightly – divide the sum of the fortnightly earnings and the amount of any allowances subject to withholding by two. Ignore any cents in the result and then add 99 cents
- monthly – obtain the sum of the monthly earnings and the amount of any allowance subject to withholding (if the result is an amount ending in 33 cents, add one cent), multiply this amount by three and then divide by 13. Ignore any cents in the result and then add 99 cents, or
- quarterly – divide the sum of the quarterly earnings and the amount of any allowances subject to withholding by 13. Ignore any cents in the result and then add 99 cents.

Then calculate fortnightly, monthly or quarterly withholding amounts as follows:

- fortnightly – determine the rounded weekly withholding amount applicable to the weekly equivalent of earnings, before any adjustment for FTB and/or tax offsets. Multiply this amount by two. (See below for FTB and tax offsets)
- monthly – determine the rounded weekly withholding amount applicable to the weekly equivalent of earnings, before any adjustment for FTB and/or tax offsets. Multiply this amount by 13, divide the product by three and round the result to the nearest dollar, and
- quarterly – determine the rounded weekly withholding amount applicable to the weekly equivalent of earnings, before any adjustment for FTB and/or tax offsets. Multiply this amount by 13.

## FAMILY TAX BENEFIT (FTB) AND TAX OFFSETS

Payees who choose to claim their entitlement to FTB and/or a tax offset through reduced withholding must provide you with a *Withholding declaration*. Tax offsets include:

- dependent spouse
- zone
- parent, spouse's parent or invalid relative
- housekeeper, and
- child-housekeeper.

If a payee has claimed their entitlement to FTB and/or a tax offset, you will need to reduce the withholding amount by:

- weekly – 1.9% of the total amount claimed at the FTB and tax offsets questions on the *Withholding declaration*, rounded to the nearest dollar
- fortnightly – 3.8% of the amount claimed at the FTB and tax offsets questions on the *Withholding declaration*, rounded to the nearest dollar
- monthly – 8.3% of the amount claimed at the FTB and tax offsets questions on the *Withholding declaration*, rounded to the nearest dollar, or
- quarterly – 25% of the amount claimed at the FTB and tax offsets questions on the *Withholding declaration*, rounded to the nearest dollar.

## ALLOWANCES

Generally allowances are added to normal earnings and the amount to be withheld is calculated on the total amount of earnings and allowances.

- 🔗 Refer to *PAYG bulletin no 1 – Taxing of allowances for the 2000/01 and future income years*.

## HELP AND SFSS DEBTS

On 1 June 2006, all accumulated Higher Education Contribution Scheme (HECS) debts became accumulated Higher Education Loan Programme (HELP) debts.

Individuals with an accumulated HELP or Student Financial Supplement Scheme (SFSS) debt may be required to have additional amounts withheld from payments you make to them. A payee with a HELP or SFSS debt will notify you of this on their *Tax file number declaration* or *Withholding declaration*.

- 🔗 Use *PAYG withholding – HELP weekly tax table* (NAT 2173) to calculate additional withholding amounts for HELP debts. Use *PAYG withholding – SFSS weekly tax table* (NAT 3306) to calculate additional withholding amounts for SFSS debts.
- ❗ Do not add amounts for HELP or SFSS when no TFN has been provided.

## HOLIDAY PAY, LONG SERVICE LEAVE AND EMPLOYMENT TERMINATION PAYMENTS

### Payees who continue working for you

For withholding purposes you must include holiday pay (including any leave loading) and long service leave payments as part of normal earnings except when they are paid on termination of employment.

Payment for leave loading is subject to withholding if it exceeds the current threshold of **\$320**. Only that part of the payment that exceeds this threshold should be subject to withholding, unless your payee provides you with a *Withholding declaration* requesting that you withhold from the full amount.

- 🔗 Refer to *PAYG withholding – calculation sheet – Index No 6209 – holiday and long service leave payments for continuing employment*.

### Payees who cease working for you

Lump sum payments made when a payee ceases working for you are not covered by this table.

If a payee has unused annual leave, leave loading or long service leave, see *PAYG withholding – Tax table for unused leave payments on termination of employment* (NAT 3351).

Any other payments made may be employment termination payments and you should refer to *PAYG withholding – Tax table for employment termination payments* (NAT 70980).

- ❗ Do not withhold any amount for HELP or SFSS debts from lump sum termination payments.

## HOW TO WORK OUT WITHHOLDING AMOUNTS

- 1 Add any allowances and irregular payments that are to be included in this week's pay to the normal weekly earnings, ignoring any cents.
- 2 Use the 'Weekly tax table with no and half Medicare levy' to find the payee's total weekly earnings in **column 1**.
- 3 Use the appropriate column to find the amount to be withheld. If the payee is claiming:
  - full Medicare levy exemption, use **column 2**, or
  - half Medicare levy exemption, use **column 3**.
- 4 Adjust the withholding amount found in step 3 if the payee:
  - has an end-of-year entitlement to FTB and/or a tax offset. See 'Family tax benefit (FTB) and tax offsets'
  - is entitled to an adjustment for the Medicare levy – half levy. See 'Medicare levy adjustment to half levy – table' on page 12, and
  - has advised you of a HELP or SFSS debt. See *PAYG withholding – HELP weekly tax table* (NAT 2173) or *PAYG withholding – SFSS weekly tax table* (NAT 3306).

## EXAMPLES

### Full exemption from the Medicare levy

A payee has weekly earnings of \$518.40. Ignoring cents, find \$518 in column 1 and read off the corresponding amount to be withheld of \$62.00 from column 2.

The payee has claimed FTB of \$500 on the *Withholding declaration*. To work out their weekly equivalent to their entitlement, take 1.9% of \$500 which is \$10 (rounded to the nearest dollar).

Subtract this amount from \$62.00 and the result of \$52.00 needs to be withheld.

### Half Medicare levy exemption

A payee has weekly earnings of \$430.90. Ignoring cents, find \$430 in column 1 and read off the corresponding amount to be withheld of \$49.00 from column 3.

The payee has claimed a tax offset of \$1,000 on the *Withholding declaration*. To work out their weekly entitlement, take 1.9% of \$1,000 which is \$19.00.

Subtract this amount from \$49.00 and the result of \$30.00 needs to be withheld.

# Medicare levy adjustment to half levy – table

## WHO SHOULD USE THIS TABLE?

Use this additional table if you make a payment to a payee who is entitled to an adjustment to their Medicare half levy. A payee is entitled to an adjustment if the payee:

- has provided you with a *Medicare levy variation declaration* in which they:
  - claimed dependants, and
  - answered 'Yes' to questions 5, 7, 10 and 12

and

- has weekly earnings of \$537 or more, but less than the corresponding amount in Column A of Table 1 below. For example, a payee who claims two dependent children must have weekly earnings of less than \$749 to be entitled to a Medicare levy adjustment.

If a payee claims more than 10 children, the column A amount is \$1,218 plus \$58 for each child claimed in excess of 10.

Column B shows the values used in calculating adjustments for payees with more than five dependent children. If a payee claims more than 10 dependent children, the column B amount is \$1,035.90 plus \$49.88 for each child in excess of 10.

See 'How to calculate the Medicare levy adjustment' below to use columns A and B.

## USING FORMULAS

The Medicare levy adjustments shown in this table can be expressed in a mathematical form.

If you have developed your own payroll software package, you will need to use the *PAYG withholding – Statement of formulas for calculating amounts to be withheld* (NAT 1004). A copy of this schedule is available from [www.ato.gov.au](http://www.ato.gov.au)

## HOW TO WORK OUT WITHHOLDING AMOUNTS

- 1 Use column 3 on pages 5 to 11 of this schedule to find the weekly amount to be withheld from the payee's weekly earnings, allowing for any FTB or tax offsets claimed.
  - 2 Reduce this amount by the amount of the Medicare levy adjustment, worked out as detailed below.
- ❶ Where the adjustment equals or exceeds the amount obtained in step 1, the amount to be withheld is nil.

## HOW TO CALCULATE THE MEDICARE LEVY ADJUSTMENT

If you make payments to your payee on a fortnightly, monthly or quarterly basis, you will need to convert their payments into weekly earnings. See 'Fortnightly, monthly or quarterly withholding amounts' on page 3.

## Payee claiming one to five dependent children

Disregarding any cents, use the 'Medicare levy adjustment to half levy – table' to find the payee's earnings in the 'Weekly earnings' column. Read off the corresponding amount of Medicare levy adjustment from the appropriate number of children column.

### EXAMPLE

The payee has weekly earnings of \$550.26 and is claiming four dependent children on the *Medicare levy variation declaration* form. Find \$550 in the 'Weekly earnings' column and read off the corresponding Medicare levy adjustment of \$1.00 from the '4 children' column.

## Payee with more than five dependent children

### 1 Weekly earnings less than \$787 – Use the '5 children' column

Disregarding any cents, use the 'Medicare levy adjustment to half levy – table' to find the payee's earnings in the 'Weekly earnings' column. Read off the corresponding amount of Medicare levy adjustment from the '5 children' column.

### EXAMPLE

The payee has weekly earnings of \$610.65 and is claiming six dependent children. Find \$610 in the 'Weekly earnings' column and read off the corresponding Medicare levy adjustment of \$4.00 from the '5 children' column.

### 2 Weekly earnings of \$787 or more but less than the column B amount that corresponds to the number of dependent children claimed

Round the weekly earnings down to the nearest dollar and add 99 cents. Take 0.75% of that amount and round to the nearest dollar.

### EXAMPLE

The payee has weekly earnings of \$791.29 and is claiming seven dependent children. Take 0.75% of \$791.99 (weekly earnings of \$791 rounded down to the nearest dollar plus 99 cents). The amount of the Medicare levy adjustment is \$6.00, rounded to the nearest dollar.

### 3 Weekly earnings of \$787 or more and greater than the column B amount but less than the column A amount that corresponds to the number of dependent children claimed

- a Take 0.75% of the relevant column B amount. Round the result to the nearest cent.
- b Take 4.25% of the difference between the weekly earnings (round down to the nearest dollar plus 99 cents) and the column B amount. Round the result to the nearest cent.
- c Subtract the result of step b from step a.
- d Round the result to the nearest dollar.

### EXAMPLE

The payee has weekly earnings of \$990.29 and is claiming eight dependent children.

- a  $0.75\% \times \$936.13$  (column B amount for eight children) = \$7.02
  - b  $4.25\% \times (\$990.99 - \$936.13)$  =  $4.25\% \times \$54.86$  = \$2.33
  - c  $\$7.02 - \$2.33$  = \$4.69
  - d \$5.00 (\$4.69 rounded to the nearest dollar).
- Therefore, the Medicare levy adjustment is \$5.00.
