PAY AS YOU GO (PAYG) WITHHOLDING

Medicare levy adjustment monthly tax table

This table should be read with the *PAYG withholding – Monthly tax table incorporating Medicare levy (NAT 1007) and the Medicare levy variation declaration (NAT 0929)*.

OR AFTER 1 JULY 2007.**



This document is a withholding schedule made by the Commissioner of Taxation in accordance with sections 15–25 and 15–30 of Schedule 1 to the *Taxation Administration Act 1953*. It applies to withholding payments covered by Subdivisions 12–B (except sections 12–50 and 12–55) and 12–D of Schedule 1.

WHO SHOULD USE THIS TABLE?

Use this table if you make payments to a payee on a monthly basis and the payee is entitled to a Medicare levy adjustment. A payee is entitled to an adjustment if the payee:

- has provided you with a *Medicare levy variation declaration* in which they:
 - claimed dependants, and
 - answered ‘Yes’ to question 10, ‘Is the combined weekly income of you and your spouse, or your income as a sole parent, less than the relevant amount in table A on page 1?’,

and

- has monthly earnings of \$1,378 or more, but less than the corresponding amount in column A of table 1. For example, a payee who claims two dependent children must have monthly earnings of less than \$3,246 to be entitled to a Medicare levy adjustment.

- ❗ No Medicare levy is payable on monthly earnings of less than \$1,378.

If a payee claims more than 10 children, the column A amount is \$5,281, plus \$255 for each child claimed in excess of 10.

Column B shows the values used in calculating adjustments for payees with more than five dependent children. If a payee claims more than 10 dependent children, the column B amount is \$4,488.92 plus \$216.17 for each child in excess of 10.

USING FORMULAS

The Medicare levy adjustments shown in this table can be expressed in a mathematical form.

If you have developed your own payroll software package, you will need to use the *PAYG withholding – Statement of formulas for calculating amounts to be withheld* (NAT 1004). A copy of this schedule is available from www.ato.gov.au

HOW TO WORK OUT WITHHOLDING AMOUNTS

- 1 Use the *PAYG withholding – Monthly tax table* (NAT 1007) to find the monthly amount to be withheld from the payee’s earnings, allowing for any family tax benefit (FTB) or tax offsets claimed.
- 2 Reduce this amount by the amount of the Medicare levy adjustment, worked out as detailed below.

- ❗ Where the adjustment equals or exceeds the amount obtained in step 1, the amount to be withheld is nil.

HOW TO CALCULATE THE MEDICARE LEVY ADJUSTMENT

Payee claiming spouse and/or one to five dependent children

Use the table beginning on page 3 to find the payee’s monthly earnings, or the nearest lower amount, in the ‘Monthly earnings’ column and read off the corresponding amount of Medicare levy adjustment from the appropriate column.

EXAMPLE

The payee has monthly earnings of \$1,405.05 and is claiming four dependent children on the *Medicare levy variation declaration*. Find \$1,405.05, or the closest lower amount (in this case \$1,404.00), in the ‘Monthly earnings’ column and read off the corresponding Medicare levy adjustment of \$4.00 from the ‘4 children’ column.

Payee with more than five dependent children

1 Monthly earnings less than \$3,410 – Use the ‘5 children’ column

Use the table beginning on page 3 to find the payee’s earnings, or the next lower amount, in the ‘Monthly earnings’ column and read off the corresponding amount of Medicare levy adjustment from the ‘5 children’ column.

EXAMPLE

The payee has monthly earnings of \$1,779.48 and is claiming six dependent children. Find \$1,779.48, or the closest lower amount (in this case \$1,776.67), in the ‘Monthly earnings’ column and read off the corresponding Medicare levy adjustment of \$26.00 from the ‘5 children’ column.

2 Monthly earnings of \$3,410 or more but less than the column B amount that corresponds to the number of dependent children claimed

Round the monthly earnings down to the next dollar amount. Take 1.5% of that amount and round to the nearest dollar.

EXAMPLE

The payee has monthly earnings of \$3,359.60 and is claiming seven dependent children. Take 1.5% of \$3,359 (the next lower dollar amount). The amount of the Medicare levy adjustment is \$50.00, rounded to the nearest dollar.

3 Monthly earnings of \$3,410 or more and greater than the column B amount but less than the column A amount that corresponds to the number of dependent children claimed

- a Take 1.5% of the relevant column B amount. Round the result to the nearest cent.
- b Take 8.5% of the difference between the monthly earnings (round down to the next dollar amount) and the column B amount. Round the result to the nearest cent.
- c Subtract the result of step b from step a.
- d Round the result to the nearest dollar.

EXAMPLE

The payee has monthly earnings of \$4,115.76 and is claiming eight dependent children.

- a $1.5\% \times \$4,056.58$ (column B amount for eight children) = \$60.85
 - b $8.5\% \times (\$4,115 - \$4,056.58)$ = $8.5\% \times \$58.42$ = \$4.97
 - c $\$60.85 - \4.97 = \$55.88
 - d \$56.00 (\$55.88 rounded to the nearest dollar).
- Therefore, the Medicare levy adjustment is \$56.
