Small Business Superannuation Clearing House

There are key dates you and your clients need to be aware of for the Small Business Superannuation Clearing House (SBSCH):

- Tuesday 10 December 2024 5:30 pm AEDT all super payments with instructions received after close of business on this date will be processed from Thursday 2 January 2025.
- Tuesday 28 January 2025 super guarantee quarterly payments are due.

Remember to check before your client's SBSCH lodgment obligations are due that you can access their account. If your client needs to complete an agent nomination and has not done so you can follow the steps in our client-to-agent linking troubleshooting guide.
