## How to get the form

To download the *Nomination of a custodian for certificate of residency or tax relief* form:

- you must have the latest version of Adobe Acrobat installed
- right-click <u>Nomination of a custodian for Certificate of Residency</u> and/or tax relief form requests (NAT 75162, PDF 1.65MB) <sup>[]</sup>
- select Save target as (or Save link as or a similar option, depending on your internet browser)
- save it to your computer.

Note: Double-clicking the link will not open this form, as the form will not load on a mobile device, tablet or within a browser.

To complete the *Nomination of a custodian for certificate of residency or tax relief* form:

- open your saved form with Adobe Acrobat Reader DC and enable JavaScript if prompted before filling in the form
- once you've completed your form, save it using the Save form button at the end of the form.

Tip: Update your default app for PDF file types to Adobe Acrobat Reader DC to open all PDF files with Adobe Acrobat.

# What you can do with this form

If you are the primary contact for a non-individual entity, you can use this form to nominate a custodian.

To confirm if your custodian is currently authorised, you can:

- view authorised contacts via our online services
- contact us.

#### What a custodian can do

A custodian (also known as a custodian organisation) can:

- prepare and submit a certificate of residency or overseas tax relief request on behalf of their client
- receive correspondence from the ATO
- communicate with the ATO through approved channels
  - online services for business if the custodian has an Australian business number (ABN)
  - ATO paper forms related to the authorised request.

## Help completing this form

Only a **primary contact** of the entity can complete this form. You can nominate one custodian on behalf of 10 entities using this form.

You can't nominate a professional (such as a legal practitioner or tax agent) as a custodian.

# How to submit the form

Once the primary contact has completed the nomination form, either:

- submit via Secure mail through ATO online services using
  - Topic Income tax
  - Subject Certificate of residency
- mail the completed nomination form to Australian Taxation Office
