# 2025 deep dive workshops - Key insights and phase 1 solution mapping

A summary of the 3 deep dive workshops conducted in 2024 was presented, covering manipulating employment relationships, digital shadow economy behaviours, and reporting and data controls.

The key insights and potential strategies derived from these workshops were presented to understand and address the drivers of prevalent shadow economy behaviours. Additional phase 1 updates were shown on the progress of implementing the proposed strategies to tackle these drivers.

#### **Bastion research findings**

The findings from the 2024 Bastion research were presented, which explored community beliefs, values and attitudes towards the shadow economy, particularly post-pandemic.

The research examined factors influencing the tolerance and reporting of shadow economy activities, the impact of digital money and cryptocurrency on the shadow economy and identified potential actionable strategies to improve compliance.

Members shared their insights aligning with the Bastion research findings, focusing on various aspects including illicit activities, the consideration of behavioural economics, suggested ways to improve communication strategies, and concerns related to administrative challenges.

#### Treasury updates on shadow economy

Treasury provided an update on work associated with the shadow economy:

- The 2017 Taskforce Report established a framework for addressing the shadow economy in Australia.
- Despite significant changes in Australia since 2017, the fundamental drivers of shadow economy behaviours remain unchanged.
- Technological advancements have introduced new challenges through digital platforms and simplified money movement.
   Addressing illicit activities, particularly those involving tobacco, is crucial to prevent escalation.

#### Agency updates

#### **Treasury**

Treasury provided an update on the consultation regarding the cash mandate for the upcoming year.

#### **Australian Border Force**

Australian Border Force (ABF) discussed the implementation of recommendations from the Nixon review. Key developments include the establishment of an Immigration Compliance Operations Division, and an Immigration Compliance Group, within the Department of Home Affairs. ABF also discussed the introduction of additional measures under the Strengthening Employer Compliance legislation effective from 1 July 2024.

#### **Australian Taxation Office**

The Australian Taxation Office (ATO) updated the forum with matters relating to the Shadow Economy Program including:

- For July to September 2024 the program has undertaken more than 79,800 activities, raising almost \$693 million in liabilities.
- Level Playing Field referrals cases have produced liability outcomes of \$12.3 million, exceeding the financial year plan of \$7 million.
- Current efforts involve addressing overstated pay as you go claims, with the potential to significantly increase the Shadow Economy deliverables subject to the scale of required treatment.
- The Shadow Economy Taskforce has made 35 disclosures to member agencies including 41 community tip-offs, in line with the Memorandum of Understanding and Regulations.

#### Member updates

Industry members shared their key observations and provided updates on various industries, highlighting the challenges faced by small businesses including:

- the need for good business practices and navigating the complexity of workplace relations
- challenges in building and construction industry, marked by high insolvency rate and ongoing difficulties, with reference to the Construction, Forestry and Maritime Employees Union.

- financial pressures on small businesses, including struggles to pay bills and taxes, with some accountants reporting cases of domestic violence, vulnerability of spouses and financial abuse
- the growing regulatory burden on small businesses and tax agents, including surcharges, over-regulation, and duplication of legislation, leading to culling of client lists due to compliance complexity and costs
- a soft recruitment market, the emergence of new non-ICP or contractor roles, and collaboration with the New Zealand Government on migrant worker initiatives.

#### Other business

The co-chair outlined upcoming activities and governance plans consisting of:

- a presentation by Dr Schaper and Tony Goding to the Council of Small Business Organisations Australia roundtable scheduled for mid-December 2024
- seeking suggestions from members of potential focus areas for 2025
- encouraging collaboration to enhance community messaging based on Bastion Research Insight
- placeholder meeting dates and potential focus areas to be advised in early 2025.

#### **Opening remarks**

A summary on findings and insights of the July workshop on 'Digital Shadow Economy Behaviours' was presented.

Co-chairs reminded members of their requirement to complete the mandatory Integrity Declaration by 30 September 2024.

#### Reporting and data controls

The Australian Taxation Office (ATO) design team led a workshop on reporting and data controls discussing:

- how businesses interact with the ATO
- understanding the current state of data controls
- the type of data being collated and shared by the ATO
- exploring possible future strategies.

The findings will be tabled at the last 2024 quarterly Shadow Economy Advisory Forum (SEAF) meeting for review and discussion with members.

#### **Member updates**

Industry members shared their key observations and provided updates on various industries, including retail and construction, highlighting the challenges faced by small businesses including:

- Cash economy concerns, noting certain businesses continue to operate primarily with cash, often leading to under-reporting.
- The impact of technology on cash transactions and the complexities faced in managing cash flow and reporting.
- Pressures of managing softer sales, higher vacancies, increase payment disputes, and the need for better support for small businesses.
- Businesses dealing with stress, leading to insolvencies and mental health issues.
- Impact of heavy regulatory changes on accountants and small practitioners which are driving small businesses away from using trusted advisors, and the importance of supporting small businesses.

#### **Treasury**

Treasury proposes to provide an update of the review at the next SEAF quarterly meeting in November.

#### **ATO**

The Shadow Economy Program has undertaken more than 245,000 activities and raised more than \$2.05 billion in liabilities.

The Illicit Tobacco Taskforce has undertaken 81 seizures supporting taskforce activities and state law enforcement agencies. These operations have seized approximately 16.7 tonne of illicit tobacco and more than 13.4 million illicit cigarettes, equating to approximately \$45 million in forgone excise.

The Shadow Economy Taskforce has made 174 disclosures to member agencies in line with the Memorandum of Understanding and Regulations.

#### Welcome

Co-chairs welcomed attendees with an acknowledgment of country. No conflicts of interest were declared. Members were reminded of confidentiality requirements.

The Shadow Economy Advisory Forum (SEAF) 2024–25 Charter was tabled with no issues and members were advised of the requirement and introduction of Integrity Declarations.

# **CPA Australia Asia-Pacific Small Business Survey for 2023–24**

CPA Australia presented on the results of the CPA Australia Asia-Pacific Small Business Survey for 2023–24 to the forum, covering:

- survey design and methodology
- small business conditions in 2023
- small business expectations in 2024
- · importance of cash to small business
- drivers of small business growth
- impact of demographics on small business performance.

#### **Australian Financial Security Authority**

Australian Financial Security Authority (AFSA) presented on the linkages to the shadow economy including:

- the AFSA's role as the Official Trustee and regulator of personal insolvency, and how it deals with shadow economy activities
- personal insolvency volumes
- linkages to shadow economy
- untrustworthy advisors, their impacts and the next steps in addressing them.

Members discussed various approaches in assisting and providing quality information to small businesses for them to access trustworthy advisors.

#### **Member updates**

Industry members shared key observations which focused broadly on current environmental pressures. The discussion noted:

- Industry bodies raised concerns of small businesses owners having limited knowledge of the reporting and tax obligations required and own industry regulations due to lack of education and low digital update usage.
- Small businesses continue to be impacted by labour shortages and recruitment challenges, with restrictions placed on migrants and international students.
- Small business owners are struggling to keep up with the volume, variety and pace of regulatory, legislative and system changes.
- Difficulty in Client Agent Linking due to fraud detecting strategies was noted, with funding announced in the 2024–25 Federal Budget to strengthen myGov and Digital Id.

#### **Agency updates**

#### **Treasury**

Treasury provided an update on the following:

- The 2024–25 Budget includes a measure extending the Shadow Economy Compliance Program for 2 years from 1 July 2026.
- The Budget documents include the Australian Government Small Business Statement which sets out a range of targeted supports for small business.

#### **Australian Border Force**

Australian Border Force (ABF) discussed the following:

- The frequency and significant quantities of vaping products being detected and the parallels with the illicit tobacco industry, including \$12.4 million worth of vapes seized in Sydney in May 2024.
- Increasing volumes of trade and its impact on border operations.
- Signing of the ABF Mutual Recognition Arrangement with India, which will speed up trade for accredited Trusted Traders who export to India.

- An overview of the issue and action being taking to address migrant worker exploitations.
- The successful prosecution in the Federal Court in relation to exploitation of the visa system.
- The ABF publication of employers involved with the exploitation of migrant works.

An ABF presentation on the topic of exploitation of migrant workers and steps to protect them from exploitation was suggested to the forum.

#### **Australian Taxation Office**

The Australian Taxation Office (ATO) updated the forum with matters relating to the Shadow Economy Program including:

- The government will provide further funding over four years from 2024–25 to continue combat scams and online fraud. Funding includes \$23.3 million for the ATO to continue to oversee and operate the secure e-Invoicing network.
- The Shadow Economy Program has undertaken more than 196,000 activities and raised more than \$1.65 billion in liabilities.
- The Illicit Tobacco Taskforce has undertaken 78 seizures supporting taskforce activities and state law enforcement agencies. These operations have seized approximately 15 tonnes of illicit tobacco and more than 11.6 million illicit cigarettes, equating to approximately \$39.7 million in forgone excise.
- The Shadow Economy Taskforce has made 135 disclosures to member agencies in line with the Memorandum of Understanding and Regulations.

- a deep dive session into Digital Shadow Economy Behaviours
- conducting a member survey to solicit feedback
- reviewing the current membership composition.

#### Focus areas in 2024

The Australian Taxation Office (ATO) presented 3 focus areas in 2024 for consideration, based on community intelligence received by the Tax Integrity Centre, covering the following areas:

- · reporting and data controls
- · digital shadow economy behaviours
- manipulating employment relationships.

A structured roadmap and program schedule were introduced to give visibility of the proposed timelines and key deliverables.

Members agreed that drivers of shadow economy behaviours are imperative to explore further.

Potential benefits of bringing regulatory agencies into the discussion, such as Treasury, were noted.

#### **Member updates**

Industry members shared observations which focussed on current environmental pressures, including:

- Ongoing skilling shortages, frequent regulatory changes and cash flow constraints continue to place pressure on many industries.
- Small business confidence is low and may decline further as influenced by the cash rate increase.
- Insolvencies and personal bankruptcies are likely to rise, as most businesses are just breaking even.
- A digital first solution may not be suitable to every business due to a lack of digital skills.
- Start-up companies require more assistance from the regulators and professionals to understand their obligations.

#### **Agency updates**

#### **Treasury**

A dedicated taskforce was established by Treasury to conduct the 5year review on shadow economy as commissioned by the government.

It will focus on new and emerging shadow economy risks and trends, while considering the recommendations made by the 2017 Taskforce Final Report.

The 5-year review is expected to be completed by June 2025.

#### **Shadow Economy Program**

The ATO has undertaken more than 105,000 activities and raised more than \$1.36 billion in liabilities.

The Illicit Tobacco Taskforce has been involved in 6 operations, which resulted in 70 seizures consisting of more than 6 tonnes of loose-leaf tobacco and over 10 million cigarettes with the total excise evaded being more than \$21 million.

The Shadow Economy Taskforce made 77 disclosures to member agencies in line with the Memorandum of Understanding and Regulations.

#### **Australian Border Force (ABF)**

The ABF will refocus on stopping threats at border through managing approximately 62 million air cargo consignments entering each year.

The importation of disposable vapes is prohibited from 1 January 2024, while the importation of all non-therapeutic vapes will be prohibited from 1 March 2024.

ABF-led Operation CALOR commenced in December 2023, which was supported by the Therapeutic Goods Administration and other partner agencies, has executed 39 Commonwealth warrants across the Sydney metropolitan area.

The SEAF co-chair outlined the governance processes in the coming months, consisting of:

updating the SEAF Charter for 2024-25

- conducting a member survey to solicit feedback
- reviewing the current membership composition.

#### Welcome

The co-chairs, Dr Michael Schaper and Will Day, welcomed attendees with an acknowledgment of country. No conflicts of interest were declared. Members were reminded of confidentiality requirements.

The endorsed SEAF Charter 2023–24 was provided to members. Changes to Agency representatives were noted and all outgoing representatives were thanked for their contribution to the forum.

#### Tax system health check

The ATO presented on the latest Shadow Economy Tax Gap findings including:

- footprints of shadow economy
- tax effects of shadow economy behaviours in the transactions and income-based taxes
- overall shadow economy taxes, including administered programs by the ATO, grew from \$14.3 billion to \$20.7 billion from 2015–16 to 2020–21
- growth in the tax effects of the shadow economy, 7.7% over 2015– 16 to 2020–21 exceeded nominal gross domestic product growth over the same period, 4.6%
- the performance is mixed across tax types with the tax effects of shadow economy tobacco excise growing very strongly, 29.6%.

#### Alcohol tax gap

The ATO discussed the alcohol tax gap including:

- high-level summary of the gap
- the net tax gap for the 2021–22 has been estimated at \$745 million, or 9.1%
- illicit alcohol activity in the shadow economy is responsible for approximately 90% of the alcohol tax gap
- primary risks and drivers
- treatment strategies implemented
- opportunity for targeted actions and improvements.

#### Member updates

Industry members shared key observations which focussed on current environmental pressures including:

- some industries are concerned with the impacts of the Industrial Relations Reforms Bill
- small businesses are struggling to keep up with the increasing reporting obligations which is shared by their professional advisors
- some small businesses are facing financial uncertainty with a rising advisory demand for professional bodies
- small businesses are impacted by cash flow issues with a growing trend in payment related disputes.

#### **Agency updates**

Treasury provided an update on the review of the Modernising Business Registers (MBR) program including:

- the final report was released in August 2023 on Treasury's website
- it was initially projected to be completed by the 2023–24 financial year at a cost of \$480.5 million
- due to several factors, including a significant underestimation of program complexity, the current costs of the MBR program are approximately 5 times the amount estimated
- the review concludes that the responsible and best available option for government is to stop the MBR program on the basis that the considerable additional investment is not justified when measured against the benefits
- it recommended the return of registry functions from the ATO to a new division in Australian Securities and Investments Commission while the director ID regime will remain under the Australian Business Registry System, with an additional targeted investment in uplifting data integrity and quality.

The ATO outlined the key achievements of the Shadow Economy Program from 1 July to 30 September 2023 including:

- We have undertaken more than 80,000 activities and raised more than \$936 million in liabilities.
- The Australian Border Force (ABF) led Illicit Tobacco Taskforce has seized just under 4 tonne of loose tobacco and over 9 million cigarettes, equating to \$15.4 million in forgone excise.

- The ATO Tax Integrity Centre have shared 969 shadow economy related community tip-offs with Shadow Economy Taskforce member agencies.
- The Shadow Economy Taskforce have made 45 disclosures to member agencies relating to illicit tobacco, money laundering, worker exploitation, visa fraud, welfare fraud and organised crime.

The ATO provided an update from the recent New Zealand Tax Conference organised by the New Zealand Inland Revenue including:

- the re-emergence of shadow economy behaviours, including cash wages and illicit tobacco were observed by New Zealand counterparts
- shared concerns on the operation of the Electronic Sales Suppression Tools
- cyber security for small businesses remains a focus, given compromised identities have been used to apply for COVID-19 support payments.

The ABF shared insights into the Australian Trusted Trader (ATT) including:

- The intent is to secure the borders and streamline legitimate trade through improving certainty in export markets and expediting the flow of the cargo in and out of Australia.
- It is administered by the ABF to accredit Australian businesses who can demonstrate compliant trade practices and a secure international supply chain.
- The ATT list represents trusted businesses who import and export, as well as those who provide services including logistics, customs brokerage and transport.

The ABF has ongoing partnerships with other agencies to protect Australia's borders including the combating illicit tobacco importation. The ATT program highlights the value of partnering with industry.

#### Other business

 The proposed meeting schedule and topics for 2024 meetings were discussed including:

- A deep dive into sham contracting and associated industry education campaigns.
- Consideration of inviting representatives of other industries to present relevant topics.
- Recommendation of avoiding any meeting scheduled for the period from 14 and 21 May due to the Federal Budget.

The Shadow Economy Advisory Forum (SEAF) co-chairs, Dr Michael Schaper and Belinda Darling, welcomed attendees and the Charter 2023–24 was tabled with no issues raised by members.

# **Australian National Audit Office discussion**

The ATO and Treasury provided an update on the recent Australian National Audit Office (ANAO) report on the effectiveness of the implementation of the government response to the 2017 Taskforce report. The ANAO made 4 recommendations. The ATO and Treasury are working together to review the ATO – Treasury Protocol. Treasury are progressing work relating to the other recommendations, which includes producing a 5-year report into the shadow economy and the ATO will be supporting this work. Members discussed the role of this forum in providing input into the 5-year report. An update will be provided at the next meeting.

#### What, how and why of elnvoicing

Mark Stockwell, Director, ATO gave a presentation on elnvoicing which covered:

- an overview of elnvoicing
- as of 30 June 2023, 32,000 Australian businesses have registered
- invoice volumes issued through elnvoicing increased by over 500% to over 400,000 for 2022–23 year
- the drivers, benefits and challenges for adoption by the community
- future focus
- targeting key industries such as recruitment and construction retailers to increase use
- working across federal government to actively engage and onboard the top 50 suppliers.

# Tax integrity centre – what the community told us

Shira Nahari, and Steve Verlingieri, Directors, ATO gave a presentation on the tax integrity centre (TIC) results which covered:

- an overview of the TIC
- trends observed and outcomes delivered under Shadow Economy Sharing Intelligence Program.

#### Member updates

Industry members shared key observations which focussed broadly on current environmental pressures. The discussion noted:

- Some industries are increasing their reliance on finance providers, with current interest rates only slightly lower than profit margins.
- Small businesses are impacted by the cost of employing staff, as compared to engaging contractors.
- Some small business owners are struggling to manage cash flow and pay their creditors and other debts, and this is leading to pressure on advisors to overstate deductions to offset changes to the low and middle income tax offset.
- Small businesses are increasing their engagement with external administrators and consultants. An increase in 'untrustworthy advisors' has been observed.

#### Agency updates

Belinda Darling, Assistant Commissioner, ATO outlined the key achievements of the Shadow Economy Program for 2022–23:

- With additional program funding the ATO has been able to raise liabilities of \$2.09 billion, with estimated cash collections of \$1.22 billion.
- The Illicit Tobacco Taskforce continues to build on its success 66 tonne of loose tobacco and more than 1.1 million cigarettes were seized during the year, equating to an estimated \$110 million in excise.
- The Shadow Economy Taskforce made almost 100 disclosures to member agencies in line with the Memorandum of Understanding and Regulations.
- The ATO have supported small businesses through online learning and the Digital Cashflow coaching kit, with an ongoing investment in

Youth, Culturally and Linguistically Diverse groups and Indigenous communities.

To support the future focus of the Shadow Economy Program strategy and design, a Shadow Economy qualitative research project is being undertaken to explore community perceptions, social beliefs and values that normalise and justify Shadow Economy behaviour. Results will be shared with this Forum.

Shadow Economy Program focus areas for the 2023-24 year:

- continue our work across agencies, including the Illicit Tobacco Taskforce
- · continue our focus on
  - hidden wages
  - omitted income and outstanding lodgments
  - illicit alcohol
- continue to identify new and emerging risks using data and analytics and other intelligence, for example, from the community.

Key messages from the Shadow Economy Advisory Forum meeting 22 May 2023

#### **Welcome and Chair update**

Co-chairs, Deputy Commissioner Will Day, Australian Taxation Office (ATO) and Dr Michael Schaper welcomed attendees. No conflicts of interest were declared. Members were reminded of confidentiality requirements.

#### Member updates

Industry members shared key observations which focussed broadly on current environmental pressures. The discussion noted:

- Small businesses continue to be impacted by labour shortages
- Small businesses continue to struggle to remain afloat, resulting in less engagement with advisors

- Increased regulation/reporting obligations are impacting small business engagement with the regulatory bodies
- Credit rating reporting has increased by 140% indicating lack of trust in business-to-business trading
- There is an uptrend in small business payment related disputes seen by the Australian Small Business and Family Enterprise Ombudsman
- Same Job, Same Pay measure (currently in consultation phase) is causing concern within member industries.

#### **Agency updates**

Will Day updated the forum with matters relating to small business and the shadow economy:

- the Shadow Economy Program was extended for a further 3 years, from 1 July 2023 (announced after the Mid-Year Fiscal Economic Fiscal Outlook)
- the Sharing Economy Reporting Regime begins on 1 July 2023 for those in the rideshare and short-term accommodation sectors
- Federal Budget 2023-24 measures:
  - Lodgment penalty amnesty program will remit failure to lodge penalties for lodgments that were due between 1 December 2019 and end of February 2022, when lodged between 1 June 2023 and 31 December 2023 for small businesses, providing them with an opportunity to re-engage with the tax office
  - Tobacco excise is set to increase by 5% per year for 3 years, starting from September 2023 which may drive shadow economy behaviours (e.g. sales of illicit tobacco).

Geoff Francis, Assistant Secretary, Treasury provided an update on the following:

Treasury is still undergoing the Australian National Audit Office
 (ANAO) audit into the 'Implementation of the government's response
 to the Black Economy Taskforce Report', with Treasury currently
 preparing a response to the ANAO section 19 report, which is
 scheduled to be tabled in parliament in June 2023

- Federal Budget 2023-24 measures of interest to the forum:
  - Extensions of several compliance programs, including:
    - Serious Financial Crime Taskforce (SFCT) and Serious
      Organised Crime (SOC) programs have been merged and extended for four years
    - GST Compliance Program extended for four years
    - Personal Income Tax Compliance program extended for two years
  - Securing Australians' Superannuation Package from 1 July 2026, employers will be required to pay their employees' superannuation guarantee entitlements on the same day that they pay the employee's salary or wage
  - Small Business Support:
    - Small Business Instant Asset Write-off threshold of \$20,000 from 1 July 2023 to 30 June 2024 for businesses with an aggregated turnover of less than \$10m
    - Small Business Energy Incentive providing an additional 20% deduction of the cost of eligible depreciating assets that support more efficient use of energy for businesses with an aggregated turnover of less than \$50m.

Tony Goding Assistant Commissioner, ATO, advised on Action Item 20230308-01 Update on direction to educate modules – how the modules were developed and who was involved in this process.

The module content and structure were developed through a gap analysis including using data from:

- the random enquiry program findings
- risk assessment and treatment plans
- existing webinar feedback from small business owners.

The modules were developed in consultation with ATO Marketing and Communications, Small Business Risk and Strategy and Technical

Leadership and Advice areas. SEAF member inclusion will be suggested when these modules are user-tested.

The Australian Border Force (ABF) were an apology for this meeting.

# **Electronic Sales Suppression Technology presentation**

Assistant Commissioner Peter Vujanic and Director Jacinta Lawson of the ATO presented on Electronic Sales Suppression Technology (ESST) to the forum, covering:

- Overview of ESST the 'what' and 'how'
- ESST legislation
- · Quantifying the tax risk, and
- ATO compliance strategy and observations.

There was general member interest in continuing to examine this issue, and in working with industry associations to alert them about this threat and ways to combat it. ESST will be discussed further in future meetings.

Gavan Ord, CPA Australia presented on the results of the CPA Australia Asia-Pacific Small Business Survey 2022-23 to the forum, covering:

- Characteristics of Australian small businesses.

Chair Will Day, welcomed attendees. No conflicts of interest were declared. Dr Michael Schaper's appointment as Chair of the Gaming and Wagering Commission of Western Australia was noted. Members were reminded of confidentiality requirements.

New members Suresh Manickam and Jason Robertson were welcomed to the forum.

#### Information protection presentation

Angelene Falk of Office of the Australian Information Commissioner (OAIC) presented to the forum, covering:

- role of OAIC
- practical steps businesses can take to protect the data they hold
- advice regarding collection, retention and verification of personal information in our increasingly digitalised environment
- level of threat, risk, damage and cost to industries caused by identity theft
- regulatory requirements for organisations to make timely assessment of data breaches and notify individuals affected by a data breach.

#### Member updates

Industry members shared key observations which focussed broadly on current environmental pressures. The discussion noted:

- businesses have less focus on their compliance obligations whilst they struggle to remain afloat
- small businesses continue to be impacted by labour shortages and supply chain issues
- merchant fees are impacting business, resulting in a movement back to a preference for cash sales
- consumer demand is trending down in value, but not in volume
- business to business trade is trending down, with businesses moving to 'just in time' inventory rather than purchasing in bulk.

#### **Agency updates**

Geoff Francis provided an update on the following:

- - The Senate Economics Legislation Committee recommended the bill be passed.
- Streamlining excise administration: Aligning reporting for smaller business and allowing small-scale takeaway beer sales ☑, consultation period 2 February 2023 to 16 February 2023
- Draft legislation <u>Strengthening the ABN system</u> ☑, consultation period 1 November 2022 to 29 November 2022.

Katie O'Brien, Australian Border Force (ABF) advised the Australian National Audit Office audit 'Implementation of the government's response to the Black Economy Taskforce Report' is ongoing.

The ABF published an Australian Customs Notice (ACN) No. 2022/42 – 'Conversion of cryptocurrencies into Australian dollars – customs valuation' advising owners who paid for their imported goods using a cryptocurrency, will need to convert this into Australian dollars based on the exchange rate for cryptocurrency on the day of exportation.

Tony Goding advised on the Sharing Economy Reporting Regime – certain ride sourcing and accommodation providers are required to report from 1 July 2023 and other platforms will report from 1 July 2024.

Direction to educate, tax-records education direction can now be used instead of imposing financial penalties, where appropriate during compliance interactions. The basic module will take approximately 45 minutes to complete.

Electronic Sales Suppression Technology work is progressing in the ATO, information about this strategy and insights gained to date will be brought to the forum in a future meeting.

#### Welcome and chair update

Co-chairs Dr Michael Schaper and Deputy Commissioner Will Day, welcomed attendees. There were no conflicts of interest declared, and members were reminded of confidentiality requirements.

Assistant Commissioner Tony Goding was introduced as the forum's new ATO advisor, replacing Peter Holt. The co-chairs thanked Peter for his efforts setting up and working with the forum.

#### **Member updates**

Industry members shared key observations which focussed broadly on current environmental pressures. The discussion noted:

- Difficulties that small businesses experience with cash flow, especially during times of natural disasters and are exacerbated by big businesses that delay paying their supplier bills.
- Supply chain issues, staffing shortages and wage rises continue to place pressure on all industries while business to business transactions remain strong.
- Businesses who pay employees in cash are vulnerable to complaints relating to non-payment of withholding tax or superannuation if the relationship breaks down.
- There are privacy concerns relating to the introduction of the public beneficial ownership registry,
- The retail sector has performed well over the past 18 months due to online shopping but expects lower consumer spending to result from rising inflation rates.
- The increase of interest rates is likely to lead to lower consumer confidence and higher cost of doing businesses, with potential consequence of insolvency wave.

## **CPA annual Asia-Pacific survey**

Gavan Ord provided an overview of the results of the 2021–22 CPA Australia's annual <u>Asia-Pacific small business survey</u> ☐. It is a quantitative survey of approximately 4,500 small businesses across Australia, New Zealand and Asia. The survey results provide an indicator of the prevalence of the (hidden) cash economy on the small business community.

Australian small businesses showed small but significant differences in comparison with other countries in the Asia-Pacific region. The survey indicated that Australian small businesses are least likely to:

- · have a significant reliance on cash sales
- earn revenue from online sales
- have reviewed their cybersecurity in the past 6 months.

The results showed that businesses with 5 to 19 employees are most likely to take cash as part of their business transactions.

The survey also indicated that Australian small businesses have a slow digital uptake, including adoption of new payment options, in comparison to other countries. Australia and New Zealand's ageing small business demographics combined with minimal new business churn may be having an impact on overall business performance.

#### Data breach concerns

The Department of Home Affairs estimates that cyber security incidents (leading to fraud and identity crime) cost the Australian economy up to \$29 billion per year. Data breaches are often carried out for the purpose of identity theft or fraud by cybercriminals who operate in the shadow economy.

A significant data breach has the potential to wipe out small to medium sized businesses, and often results in lost revenue and interrupted services, as well as significant reputational damage. The penalties imposed for data breaches are also becoming tougher.

The forum discussed the difficulties small business owners experience in managing cyber security threats and identified 3 focus areas for future discussion:

- the need for education on the practical steps that small businesses can take to protect the data they hold
- the general pressures of increasing costs as an inhibitor to investing in cyber security (for example, CPA Australia's annual Asia-Pacific small business survey results identified that only around 35% of Australian small businesses have reviewed their cybersecurity in the past 6 months)
- how small businesses can protect themselves from unscrupulous cyber security professionals who seek to exploit business vulnerabilities
- advice regarding retention and/or verification of personal and commercial information in an increasingly digitalised environment.

The Office of the Australian Information Commissioner has been invited to speak to the forum.

## **Effective media and messaging**

Stuart Austin, Media Unit, ATO discussed the ATO's proactive media approach and the July 2022 media release **Tipped off: ATO reveals most dobbed-in industries**. The release gained excellent traction across national and local media outlets with a potential audience reach of 11.6 million. It demonstrates how an effective proactive media strategy can be used to advocate matters relating to the shadow economy.

The success of the proactive media approach was due to several factors:

- a newsworthy topic to attract attention with new information or data
- providing the media release under embargo to a trusted journalist
- content that is easy for journalists to use for news stories
- availability of a trained media spokesperson.

The ATO will use this approach in future releases on topics relating to the shadow economy, for example: industry-specific, regional and prosecutions.

Members are invited to partner with the ATO to develop industryspecific approaches.

## **Agency updates**

Tony Goding advised that the agency is participating in the Australian National Audit Office's (ANAO's) audit of the Black Economy Taskforce recommendations. The ANAO is assessing the effectiveness of the implementation of the government response to the Black Economy Taskforce report.

The update also included an overview of the October 2022–23 Australian Government Budget ATO measures. The Shadow Economy funding has been extended for 3 years from 1 July 2023. The ATO will continue to support to the Black Economy Standing Taskforce and its

compliance approaches to levelling the playing field for small businesses.

Funding has also been provided to the ATO to continue leading the Tax Avoidance Taskforce, address over-claiming of personal income tax deductions and participate in the Fusion Taskforce (which will focus on National Disability Insurance Agency non-compliance).

Katie O'Brien, Australian Border Force (ABF) advised the agency is also participating in the ANAO's audit of the Black Economy Taskforce recommendations.

The forum was advised that ABF also has a community tipoff facility, <a href="Borderwatch">Borderwatch</a> ☑, which captures reports of suspicious border activities.

Geoff Francis confirmed that Treasury is also participating in the ANAO's audit of the Black Economy Taskforce recommendations. It was noted that the review of legislation banning the use of electronic suppression software is close to completion.

## Welcome and chair update

Co-chairs Dr Michael Schaper and Assistant Commissioner Peter Holt welcomed attendees. No conflicts of interest were declared by the members.

New members Laura Berger-Thomson, Department of Treasury, Kimberlee Stamatis, Australian Border Force and Simon Butt, Master Builders Association were introduced to the forum.

Deputy Commissioner Will Day was announced as the new co-chair as Deborah Jenkins has moved to a new role.

Members were reminded of confidentiality requirements associated with forum discussions. Should information be required for circulation outside this forum, members are to engage co-chairs who will ensure appropriately classified information is provided for dissemination.

It was noted that the members agreed to extend the tenure and membership of the forum by 12 months, until 30 June 2023.

## Member updates

Industry members shared key observations which focussed on factors contributing to a highly challenging business environment. The discussion included:

- raising awareness of the shadow economy by focusing on the behaviour rather than the industry of those high-risk businesses
- cross agency communications and the reference to shadow or black economy (using different words to resonate depending on the industry)
- acknowledging that the terminology could be tailored to the industry and audience to identify the associated shadow economy behaviours
- the impacts of natural disasters and the ongoing pandemic on the mental wellbeing of small business owners and broader community
- businesses are struggling due to a lack of financial literacy
- people may be reluctant to re-engage with the tax system due to a fear of potential consequences
- the construction industry is facing labour and material shortages, including supply chain issues due to the pandemic and the war between Russia and Ukraine

 cash is being used by both employers and employees to avoid some obligations.

## **Environmental scan**

It was noted that the current environment could result in some businesses shifting their behaviours towards the shadow economy.

Australia's seasonally adjusted unemployment rate was at a record low of 3.5% in June 2022. The inflation rate has increased to 6.14% and the current Reserve Bank of Australia cash rate is 1.85%.

Members noted that the impacts of these issues vary across each sector so messaging needs to be tailored. It is important to communicate the right message for those who want to be honest and provide them with guidance.

Digital systems also have an impact. There is a reluctance, especially in older generations, to onboard new technology. Positive social media messages could engage with millions and target different industries. Communication should be limited to 3 messages at a time as this is more beneficial / easy to recall. The building and construction industry

is one of the most reluctant industries to trust digital systems. This is being addressed by providing social media training and education on good business via apprenticeships and in-game messaging.

Members noted that direct messages at the right channels are beneficial towards nudging them to towards legitimacy.

## **Community research**

The ATO conducted research before the COVID-19 pandemic to better understand the shadow economy behaviour, drivers, and demographics of the population. Members were asked to comment on another round of research.

It was noted that consumer behaviour has shifted away from cash over the last few years, but the value of Australian banknotes has increased (up nearly 20% since the start of the pandemic). Many view the cash economy as a victimless crime, with no harm caused or disadvantages to them.

Business and social peer groups can have the greatest influences on a community's belief and behaviour in the cash economy.

Members noted the previous research and expected the same findings will result. They emphasised that it is the behaviour that needs to shift, and this will not change until cultural, technological or generational change eventuates and therefore it is vital to understand the moral reasoning behind the behaviour.

## **Agency updates**

Geoff Francis, Assistant Secretary Treasury provided an update on the Sharing economy reporting regime and the 'direction to educate' legislation.

The legislation has now passed the House of Representatives and been introduced to the Senate.

Kimberlee Stamatis advised that on 1 June 2022 Hon Claire O'Neill was appointed as the Minister for Home Affairs. Hon Andrew Giles is the new Minister of Immigration. It was also noted that because of Machinery of Government changes, the Freedom from Modern Slavery policy now sits with the Attorney General's Department.

Peter Holt advised the 4 year program of funding provided to the ATO to implement the recommendations included in the Black Economy Taskforce Report finished on 30 June 2022. The program raised additional liabilities of \$3.8 billion. New measures to increase voluntary compliance and data and analytics profiling have improved the identification of participants and made it more difficult to participate in the shadow economy.

Members were presented with a pack of draft messaging artefacts for discussion and feedback along with a calendar of potential speaking opportunities. The draft messages were in an industry-voice, designed to be delivered from members other than the ATO.

Members identified that the term 'shadow economy' may not resonate with all business owners in their industries and suggested using the term 'cash economy' or other alternatives. It was acknowledged that terminology could be tailored to the industry and audience to identify the associated shadow economy behaviours. The growing use of electronic sales suppression tools as growing risk was also raised, acknowledging that the shadow economy is more than the 'cash economy'.

Members agreed firm language is needed to highlight that under reporting activities is a criminal offence, which is not victimless nor good business practice. There was discussion about some international examples. Other suggestions included to make messaging personal/emotive, focus on the ramifications and punishments for engaging in criminal activities, and to explore using behavioural economics to develop messages that would influence the audience. Members also raised additional speaking opportunities for the calendar.

## **Member updates**

Industry members shared key observations which focussed on factors contributing to a highly challenging business environment. This included:

- high inflation not previously encountered by business owners
- wage increases, rising fuel costs, increasing cost of supplies, increase in interest rates, supply chain disruptions, profit margin pressures, insurance affordability, access to finance
- payment of deferred rents and likelihood of annual rental increases based on Consumer Price Index in the coming year
- future changes to the super guarantee percentage and the removing the \$450 per month threshold for super guarantee
- difficulty in attracting and retaining staff is an issue with many industries seeing demand for their services/products at or exceeding pre-pandemic levels, but they are unable to meet demand due to staff and or skill shortages
- COVID-19 has meant changing business models, including hybrid models to ensure on-going sustainability.

## Agency updates

Geoff Francis, Assistant Secretary Treasury advised the legislation to introduce a sharing economy reporting regime and the legislation to enable the Commissioner of Taxation to direct an entity to complete an approved record-keeping course as an alternative to financial penalties, known as direction to educate, did not pass the Senate prior to the election being called. This will be progressed with the incoming government, along with the review of the Increasing the integrity of the Commonwealth procurement process measure.

Geoff also advised that the Strengthening the Australian Business Number (ABN) system measure start date has been delayed by 12 months as announced in the recent federal budget.

Vanessa Holben, Customs, Australian Border Force (ABF) advised that the ABF Commissioner will deliver the keynote address at the inaugural International Forwarders and Customs Brokers Association of Australia conference on 20 May 2022. Data connectedness with industry will be a focus of the address. Vanessa also advised that integrity in supply chains would be an ABF focus next year and agreed to speak with members out of session on the topic of modern slavery.

Deb Goldfinch, Director ATO advised that additional funding was received for a 12 month shadow economy work program as part of Mid-Year Economic and Fiscal Outlook with focus on our compliance program, and prevention work.

Deborah Jenkins, Deputy Commissioner ATO provided members with information about Operation Protego. Deborah thanked members for sharing the recent media release and highlighted that work was underway to address the proliferation of this GST refund fraud risk, including working with banks and social media platforms. A hotline is in place and people are asked to contact the hotline if they have engaged in this behaviour inadvertently.
