

Notification of a new eligible tier-1 company of a multiple entry consolidated (MEC) group

A MEC group is a group of Australian entities that is wholly foreign-owned and does not have a common Australian resident head company.

If a member of the MEC group has petroleum resource rent tax (PRRT) obligations (for onshore petroleum project interests), you can choose to consolidate for PRRT purposes, if the group is not already consolidated for those purposes.
