

### Statement of tax record application form – for new Australian and international tenderers without an Australian TFN or ABN

If you do not have an Australian tax file number (TFN) or Australian business number (ABN), use this form to request a statement of tax record (STR).

We will email your STR within 4 working days.

#### You must complete all fields.

- Don't use this form if either you:
  - have a TFN or ABN instead <u>apply for an STR</u> through ATO online services
  - are applying as a corporate trustee (as you must have an active TFN to receive a satisfactory STR) – instead, apply for a tax file number then request an STR.
