Notification of formation of an income tax consolidated group

Do not use this notification if you want to notify the formation of a multiple entry consolidated (MEC) group. A MEC group is a group of Australian entities that is wholly foreign-owned and does not have a common Australian resident head company. You must use *Notification of formation of a multiple entry consolidated (MEC) group* (NAT 7024).

If a member of the consolidated group has minerals resource rent tax (MRRT) obligations and/or petroleum resource rent tax (PRRT) obligations (for onshore petroleum project interests), you can also choose to consolidate for MRRT and/or PRRT purposes.

Who should complete this form


