

Loss carry back claim form – 2020–21 Early balancer substituted accounting period or lodging a company tax return for part year

Use this form to notify us of a loss carry back tax offset being claimed in connection with the lodgment of a company tax return before 1 July 2021. This form is only to be used by companies who either:

- have an approved early balancer substituted accounting period (SAP)
- need to lodge a company tax return for part of the 2020–21 income year.

This form should be completed by the public officer or tax agent of the company.
