Where the tax-free threshold is claimed and the employee earns:

- more than \$12,675.00 but less than \$15,829.67 withhold \$3,393 plus 39 cents for each \$1 of earnings in excess of \$12,675.00
- more than \$15,829.66, withhold \$4,624 plus 47 cents for each \$1 of earnings in excess of \$15,829.66.

Where the tax-free threshold is not claimed and the employee earns:

- more than \$12,675.00 but less than \$14,313.00 withhold \$3,978 plus 39 cents for each \$1 of earnings in excess of \$12,675.00
- more than \$14,312.99, withhold \$4,619 plus 47 cents for each \$1 of earnings in excess of \$14,312.99.

For all withholding amounts calculated, round the result to the nearest dollar.
