Australian Government Australian Taxation Office Declaration for an exemption from luxury car tax – cars used for transporting people with a disability in wheelchairs

WHO SHOULD USE THIS DECLARATION?

If you are an eligible person with a disability and you use a wheelchair, present this declaration to your motor vehicle supplier so they do not have to charge luxury car tax (LCT) on the car. Generally, if you have purchased the car GST-free, you will not be eligible to an exemptionfrom luxury car tax.

You may also use this declaration if you are buying a car that is specifically modified for transporting a person with a disability seated in a wheelchair. For example, if you are a carer for an eligible person with a disability who uses a wheelchair.

You do not need to send this declaration to the Tax Office. This declaration needs to be kept by your supplier as the authority for supplying the car LCT-free to you. You need to sign and date the declaration.

We recommend you keep a copy of this declaration and any supporting documents for your records.
