Things you need to know before you complete your application

- Read the information on our website about Release from your tax debt.
- Lodge all your outstanding income tax returns and activity statements so we know the total amount you owe.
- If you have an unresolved dispute with us it will need to be finalised first.
- You can continue to make payments towards your tax debt while we consider your application.
- It is not an offence not to provide your tax file number (TFN) but not doing so may delay your application. The ATO is authorised by the *Taxation Administration Act 1953* to ask you for the information in this form.
