

### Notification of provisional head company no longer eligible

A multiple entry consolidated (MEC) group is a group of Australian entities that is wholly foreign-owned and does not have a common Australian resident head company.



Do not use this form to notify us:

- if you are an income tax consolidated group. You must use Notification of head company no longer eligible: income tax consolidated group ceases to exist (NAT 6783)
- of the formation of the original MEC group. You must use Notification of formation of a multiple entry consolidated (MEC) group (NAT 7024)
- of eligible tier-1 companies who have joined the group after its formation. You must use Notification of a new eligible tier-1 company of a multiple entry consolidated (MEC) group (NAT 73442).
