Where the tax-free threshold is claimed and the employee earns:

- more than \$6,800 but less than \$7,306, withhold \$1,936 plus 39 cents for each \$1 of earnings in excess of \$6,800
- more than \$7,305, withhold \$2,134 plus 47 cents for each \$1 of earnings in excess of \$7,305.

Where the tax-free threshold is not claimed and your employee earns more than \$6,800, withhold \$2,222 plus 47 cents for each \$1 of earnings in excess of \$6,800.

For all withholding amounts calculated, round the result to the nearest dollar.
