It is replaced by Taxation Determination TD 94/76 Income tax: capital gains: when is an asset regarded as 'acquired by a taxpayer in replacement of an asset disposed of by the taxpayer' for the purposes of section 160ZZK of the *Income Tax Assessment Act 1936*?
