## Class Ruling

### Income tax: deductibility of donations to Launch Housing Limited under a Payment Direction Deed

This Erratum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It corrects Class Ruling CR 2016/42 to address typographical errors.

#### **CR 2016/42 is corrected as follows:**

**1. Paragraph 55**

Omit “a registered public benevolent institution”; substitute ‘a registered public benevolent institution’.

**2. Paragraph 57**

Omit “A registered public benevolent institution”; substitute ‘A registered public benevolent institution’.

**3. Paragraph 66**

Omit ‘section 247’; substitute ‘section 30-247’.
