### Law Companion Guideline

## Managed Investment Trusts: widely-held tests – wholly-owned entity of an Australian government agency

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It amends Law Companion Guideline LCG 2015/14 to remove references to Law Companion Guideline due to change of name to Law Companion Ruling.

#### LCG 2015/14 is amended as follows:

##### 1. Title (including headers and footers)

Omit 'Law Companion Guideline LCG 2015/14'; substitute 'Law Companion Ruling LCR 2015/14'.

Omit all occurrences of 'Guideline'; substitute 'Ruling'.
