Law Companion Guideline

Attribution Managed Investment Trusts: the rules for working out trust components – allocation of deductions

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It amends Law Companion Guideline LCG 2015/8 to remove references to Law Companion Guideline due to change of name to Law Companion Ruling.

LCG 2015/8 is amended as follows:

1. Title (including headers and footers)

Omit 'Law Companion Guideline LCG 2015/8'; substitute 'Law Companion Ruling LCR 2015/8'.

3. Entire document
