## Draft Taxation Determination

**Income tax: what is the deductible amount under section 27H of the *Income Tax Assessment Act 1936* (ITAA 1936) of a superannuation pension that is taken to have commenced when a superannuation pension is split pursuant to an agreement or court order on marriage breakdown?**

Draft Taxation Determination TD 2002/D14 is withdrawn with effect from today.

The Tax Office is currently reviewing a number of issues concerning the recent amendments to the *Income Tax Assessment Act 1936* to give effect to the taxation of superannuation benefits that are split on marriage breakdown. The review has cast sufficient doubt on the matters addressed in TD 2002/D14 and the two related draft Taxation Determinations, TD 2002/D13 and TD 2002/D15 that they should be withdrawn pending the outcome of the review.
