Goods and Services Tax Advice

Goods and services tax: if a vendor sells a farm as a GST-free supply of a going concern and the farmland includes residential premises that are not part of the business, is an adjustment required under Division 135 of the GST Act?

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953.* It amends Goods and Services Tax Advice GSTA TPP 092 to update the Date of Effect section to reflect the amendments within the *Tax Laws Amendment (2010 GST Administration Measures No. 2) Act 2010* which came into effect on 1 July 2010.
