## Addendum

### **Goods and Services Tax Ruling**

Goods and services tax: agency relationships and the application of the law

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It amends Goods and Services Tax Ruling GSTR 2000/37 to update the Date of effect section to reflect the amendments within the *Tax Laws Amendment (2010 GST Administration Measures No. 2) Act 2010* which came into effect on 1 July 2010.

#### GSTR 2000/37 is amended as follows:

#### 1. Paragraphs 9 to 9B

Omit the paragraphs; substitute:

- 9. This Ruling applies [to tax periods commencing] both before and after its date of issue. However, this Ruling will not apply to taxpayers to the extent that it conflicts with the terms of a settlement of a dispute agreed to before the date of issue of this Ruling (see paragraphs 75 and 76 of Taxation Ruling TR 2006/10).
- 9A. Changes made to this Ruling by Addenda that issued on 26 March 2003 (as corrected by an Erratum that issued on 28 March 2003), 15 August 2007, 2 April 2008 and 31 October 2012 have been incorporated into this version of the Ruling.<sup>1A</sup>
