Product Ruling

Income tax: Film Investment – McLeod’s Daughters Investment 2005

Preamble

The number, subject heading, **What this Product Ruling is about** (including **Tax law(s)**, **Class of persons** and **Qualifications** sections), **Date of effect**, **Withdrawal**, **Arrangement** and **Ruling** parts of this document are a ‘public ruling’ in terms of Part IVAAA of the **Taxation Administration Act 1953**. Withdrawal

This is subject to there being no change in the arrangement or in the persons’ involvement in the arrangement.
