Product Ruling

The Product Rulings system

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It amends Product Ruling PR 2007/71 to clarify and incorporate procedural and policy updates that have occurred since it issued.

PR 2007/71 is amended as follows:

1. Paragraph 47

Omit the paragraph heading and paragraph.

2. Paragraph 57

Omit the paragraph; substitute:

57. In the first instance an entity intending to apply for a product ruling is encouraged to contact the ATO prior to submitting a formal application. Search for 'how to apply for a product ruling' on the ATO's internet site (www.ato.gov.au) to obtain details of the application process, information requirements and how to obtain assistance if required.

3. Paragraphs 58 to 67

Omit the paragraphs.
