What this Ruling is about

1. This Product Ruling sets out the Commissioner's opinion on the way in which the relevant provision(s) identified in the Ruling section apply to the defined class of entities, who take part in the scheme to which this Ruling relates. All legislative references in this Ruling are to the *Income Tax Assessment Act 1997* (ITAA 1997) unless otherwise indicated.
2. In this Product Ruling this scheme is referred to as the 2006 Swan Hill Almond Grower Project – 2006 Growers or simply as 'the Project'.

Class of entities

3. This part of the Product Ruling specifies which entities can rely on the tax benefits set out in the Ruling section of this Product Ruling and which entities cannot rely on those tax benefits. In this Product Ruling, those entities that can rely on the tax benefits set out in this Ruling are referred to as Growers.
4. The class of entities who can rely on those tax benefits consists of those entities who were specifically identified in paragraph 58 of Product Ruling PR 2006/14 and who entered into the specific scheme that is set out in paragraphs 15 to 57 of that Ruling on or after 8 March 2006 and on or before 15 June 2006.
5. The class of entities who can rely on the tax benefits set out in the Ruling section of this Product Ruling does **not** include entities who:
 - intend to terminate their involvement in the scheme prior to its completion, or who otherwise do not intend to derive assessable income from it;
 - were accepted into this Project before 8 March 2006 or after 15 June 2006;
 - have participated in the scheme through offers made other than through the Product Disclosure Statement; or
 - have elected to take their own almonds.

Qualifications

6. The class of entities defined in this Product Ruling may rely on its contents provided the scheme actually carried out is carried out in accordance with the scheme described in paragraphs 15 to 57 of PR 2006/14.

7. If the scheme actually carried out is materially different from the scheme that is described in this Product Ruling, then:

- this Product Ruling has no binding effect on the Commissioner because the scheme entered into is not the scheme on which the Commissioner has ruled; and
- this Product Ruling may be withdrawn or modified.

Date of effect

9. This Product Ruling applies only to the specified class of entities that entered into the scheme set out in paragraphs 15 to 57 of PR 2006/14 on or after 8 March 2006 and before 15 June 2006.

10. However the Product Ruling only applies to the extent that there is no change in the scheme or in the entity's involvement in the scheme.

Ruling

Continuing application of PR 2006/14

11. Although now withdrawn, the tax benefits set out in Product Ruling PR 2006/14 continue to apply to participants who are within the specified class of entities to which the Product Ruling applied and who entered into the specified scheme on or after 8 March 2006 and on or before 15 June 2006. This is subject to there being no material difference in the scheme or in the entities involvement in the scheme.

Division 35 – deferral of losses from non-commercial business activities

Section 35-55 – exercise of Commissioner’s discretion

2005-06 to 2009-10 income years

12. Subject to the Project being carried out in the manner described in this Ruling, the Commissioner will exercise the discretion in paragraph 35-55(1)(b) for Growers as it applied at 31 August 2011, the date this Ruling was made, for the 2005-06 to 2009-10 income years. This conditional exercise of the discretion will allow those losses to be offset against the Grower’s other assessable income in the income year in which the losses arise.

2010-11 to 2012-13 income years

13. For the 2010-11 to 2012-13 income years, the Commissioner will exercise the discretion in subsection 35-55(1) once the following conditions are satisfied:

- the Grower carried on their business of primary production during the income year; and
- the business activity that is carried on is not materially different to that in the scheme described in this Ruling; and
- the Grower has incurred a taxation loss for the income year from carrying on that business activity.

14. If these conditions are met for the 2010-11 to 2012-13 income years, the Commissioner will exercise the discretion for that year under:

- paragraph 35-55(1)(b) for a Grower in the Project who satisfies the income requirement in subsection 35-10(2E); and
- paragraph 35-55(1)(c) for a Grower in the Project who does not satisfy the income requirement in subsection 35-10(2E).

15. If the Commissioner determines that the discretion will not be exercised for a particular year or years the Grower will be informed of that decision and the reasons. In any year where the discretion is not exercised losses incurred by a Grower will be subject to the loss deferral rule in section 35-10 and the Grower will not be able to offset the losses from the Project against other assessable income.

The issue of this Product Ruling of itself does not constitute the exercise of the Commissioner’s discretion in subsection 35-55(1) for any income year.

Scheme

16. The scheme that is the subject of this Ruling is called the 2006 Swan Hill Almond Grower Project – 2006 Growers and is described in paragraphs 15 to 57 of PR 2006/14. It also incorporates the following additional documents:

- application for a Product Ruling dated 19 July 2011; and
- correspondence and information received on 19 August 2011.

Note: certain information has been provided on a commercial-in-confidence basis and will not be disclosed or released under Freedom of Information legislation.

17. For the purposes of describing the scheme to which this Ruling applies, there are no other agreements, whether formal or informal, and whether or not legally enforceable, which a Grower or any associate of a Grower, will be a party to, which are a part of the scheme.

18. All Australian Securities and Investment Commission requirements are, or will be, complied with for the term of the agreements.

Appendix 1 – Explanation

❶ *This Appendix is provided as information to help you understand how the Commissioner's view has been reached. It does not form part of the binding public ruling.*

Deferral of losses from non-commercial business activities and the Commissioner's discretion

Sections 35-10 and 35-55

19. Based on information provided with the application for this Product Ruling, a Grower who was accepted into the Project on or after 8 March 2006 and on or before 15 June 2006 and carries on a business of primary production individually (alone or in partnership) is expected to incur losses from their participation in the Project for each of the income years from 2005-06 to 2012-13 which will be subject to Division 35.¹ These losses will be subject to the loss deferral rule in section 35-10 unless an exception applies or, for each income year in which losses are incurred, the Commissioner exercises the discretion in subsection 35-55(1) on 30 June of that specific income year.

20. The exceptions to the loss deferral rule depend upon the circumstances of individual Growers and are outside the scope of this Product Ruling.

21. The Commissioner will apply the principles set out in Taxation Ruling TR 2007/6 Income tax: non commercial business losses: Commissioner's discretion when exercising the discretion.

22. For the 2005-06 to 2009-10 income years, a Grower who incurs a loss in an income year from carrying on their business activity in a way that is not materially different to the Scheme described in the Ruling, and the discretion in paragraph 35-55(1)(b) as it applied is exercised for that year, the Commissioner will be satisfied that:

- it is because of its nature that the business activity of the Grower will not satisfy one of the four tests in Division 35; and
- there is an objective expectation that within a period that is commercially viable for the primary production industry, the Grower's business activity will satisfy one of the four tests set out in Division 35 or produce assessable income for an income year greater than the deductions attributable to it for that year (apart from the operation of subsections 35-10(2) and (2C)).

¹ Division 35 does not apply to Growers who do not carry on a business or who carry on a business other than as individuals (alone or in partnership).

23. In the 2009-10 income year an income requirement was introduced to Division 35. This income requirement will apply to Growers in the Project from the 2010-11 to 2012-13 income years. Where a Grower with income for NCL purposes of less than \$250,000 (that is, the Grower satisfies the income requirement in subsection 35-10(2E)) incurs a loss in an income year from carrying on their business activity in a way that is not materially different to the Scheme described in this Product Ruling, and the discretion in paragraph 35-55(1)(b) is exercised for that year, the Commissioner will be satisfied that:

- it is because of its nature that the business activity of the Grower will not satisfy one of the four tests in Division 35; and
- there is an objective expectation that within a period that is commercially viable for the primary production industry, the Grower's business activity will satisfy one of the four tests set out in Division 35 or produce assessable income for an income year greater than the deductions attributable to it for that year (apart from the operation of subsections 35-10(2) and (2C)).

24. For the 2010-11 to 2012-13 income years, where a Grower with income for NCL purposes of \$250,000 or more (that is, the Grower does not satisfy the income requirement in subsection 35-10(2E)) incurs a loss in an income year from carrying on their business activity in a way that is not materially different to the scheme described in this Product Ruling, and the discretion in paragraph 35-55(1)(c) is exercised for that year, the Commissioner will be satisfied that:

- it is because of its nature that the business activity of the Grower will not produce assessable income greater than the deductions attributable to it; and
- there is an objective expectation that within a period that is commercially viable for the primary production industry, the Grower's business activity will produce assessable income for an income year greater than the deductions attributable to it for that year (apart from the operation of subsections 35-10(2) and (2C)).

25. A Grower will satisfy the income requirement in subsection 35-10(2E) where the sum of the following amounts is less than \$250,000:

- taxable income for that year (ignoring any loss arising from participation in the Project or any other business activity);
- total reportable fringe benefits for that year;
- reportable superannuation contributions for that year; and

- total net investment losses for that year.

26. In each individual year where the Commissioner's discretion is exercised a Grower within either paragraph 23, paragraph 24 or paragraph 25 of this Ruling who would otherwise be required to defer a loss arising from their participation in the Project under section 35-10 until a later income year is able to offset that loss against their other assessable income.
