# Notice of Withdrawal

## Taxation Determination

Income tax: section 8-1 of the *Income Tax Assessment Act 1997*: capital protected loan facility with a reset feature: interest deductibility

Taxation Determination TD 2005/5 is withdrawn with effect from today.

1. TD 2005/5 deals with the interim measures relating to changes announced in 2003 in respect of the treatment of capital protected borrowings. Specifically, it addresses when interest payable on a capital protected loan facility with a reset feature is deductible under section 8-1 of the *Income Tax Assessment Act 1997* (ITAA 1997).
2. Capital protected borrowings are now dealt with by Division 247 of the ITAA 1997.
3. TD 2005/5 has no ongoing relevance, and is therefore withdrawn without replacement.
