It amends Taxation Ruling TR 2008/9 to replace a reference to withdrawn Taxation Ruling TR 2004/15 *Income tax: residence of companies not incorporated in Australia - carrying on business in Australia and central management and control* with new Taxation Ruling TR 2018/5 *Income tax: central management and control test of residency*.
