Taxation Ruling

Income tax: employee building workers - allowances, reimbursements, long service payments, redundancy trust payments and work-related deductions

Taxation Ruling TR 95/22 is withdrawn with effect from 19 June 2025.

1. This Ruling provides views on:
 - the assessability of allowances, reimbursements, long service payments and redundancy trust payments received by employee building workers
 - deductions for work-related expenses commonly claimed by employee building workers.
2. The Ruling is no longer current due to developments in case law and legislation. The Ruling is therefore withdrawn.
