### **Class Ruling**

Income tax: Approved Early Retirement Scheme – Victorian Police Department

#### **Preamble**

The number, subject heading, and the What this Class Ruling is about (including Tax law(s), Class of persons and Qualifications sections), Date of effect, Withdrawal, Arrangement and Ruling parts of this document are a 'public ruling' in terms of Part IVAAA of the Taxation Administration Act 1953. ## Withdrawal

1. This Ruling is withdrawn and ceases to have effect after 31 January 2002. Thus, the Ruling continues to apply to those persons, even following its withdrawal, for arrangements entered into prior to withdrawal of the Ruling. This is subject to there being no change in the arrangement or in the persons' involvement in the arrangement.
