## What this Ruling is about

1. This Ruling sets out the Commissioner's opinion on the way in which the relevant provisions identified below apply to the defined class of entities, who take part in the scheme to which this Ruling relates.

### Relevant provision(s)

- 2. The relevant provisions dealt with in this Ruling are:
  - section 6-5 of the Income Tax Assessment Act 1997 (ITAA 1997);
  - section 8-1 of the ITAA 1997; and
  - section 15-2 of the ITAA 1997.

All legislative references in this Ruling are to the ITAA 1997 unless otherwise indicated.

### **Class of entities**

3. The class of entities to which this Ruling applies is all individuals who receive payments from the Northern Tasmanian Football League (NTFL) to officiate Australian Rules football matches as umpires in the North West region of Tasmania.

4. Those entities described in paragraph 3 of this Ruling to whom this Ruling applies are collectively referred to in this Ruling as umpires.

### Qualifications

5. The Commissioner makes this Ruling based on the precise scheme identified in this Ruling.

6. The class of entities defined in this Ruling may rely on its contents provided the scheme actually carried out is carried out in accordance with the scheme described in paragraphs 10 to 24 of this Ruling.

7. If the scheme actually carried out is materially different from the scheme that is described in this Ruling, then:

- this Ruling has no binding effect on the Commissioner because the scheme entered into is not the scheme on which the Commissioner has ruled; and
- this Ruling may be withdrawn or modified.

## **Date of effect**

9. This Ruling applies from 1 March 2010. However, this Ruling will not apply to taxpayers to the extent that it conflicts with the terms of a settlement of a dispute agreed to before the date of issue of this Ruling (see paragraphs 75 and 76 of Taxation Ruling TR 2006/10).

### Scheme

10. The following description of the scheme is based on information provided by the applicant in the application for class ruling dated 31 March 2010 and additional information provided by way of facsimile dated 14 May 2010.

11. The North West Umpires Association (NWUA) was initially formed to administer and co-ordinate umpiring development in the North West region of Tasmania.

12. The NWUA provides Australian Rules football umpires to the NTFL situated in the North West region of Tasmania.

13. The NTFL pays umpires who have been engaged to umpire the NTFL fixtures.

14. The NTFL on behalf of the NWUA retains a percentage of fees to cover administration costs, coaching costs and ground and club room rental. The balance of fees is paid to the umpires as match fees, via electronic funds transfer, into their nominated financial institution. Payment of fees is usually 7 days from the end of each calendar month.

15. Umpires are paid a match fee for each game they umpire and amounts received in a season depend on the level and number of games at which an umpire officiates. Current fees are such that the expected ceiling of amounts any umpire would receive in a season is less than \$3,000.

16. Umpires do not receive any allowances or benefits other than their match fees and travel allowances. No allowances are received by the umpires for tribunal attendance or training.

17. The travel allowance, which is currently set at \$0.40 per kilometre, is paid to umpires that are nominated drivers for a particular game.

18. All umpires are financial members of the NWUA. Membership fees are set at the Annual General Meeting each year, and are payable by all umpires.

19. Current membership fees are set at \$10 for adults. Membership fees assist in the administration of the NWUA.

20. Umpires are in all cases appointed to matches by the NWUA and no club or League has any influence over which umpires are appointed to which games.

21. All appointments are based on performance and experience, whereby the most experienced umpires are usually appointed to senior games.

22. Umpire's performance is continually reviewed by coaching staff for assessment and improvement. The review process is applicable to all levels of umpiring.

23. The cost for umpiring uniforms is deducted from match fees. Uniforms include match day apparel as well as umpiring uniforms. Other costs incurred by umpires including training gear and travel to training are paid for by the individual umpires.

24. The purpose of the payments made by the NTFL is to encourage members of the wider community to participate in local sporting activities by subsidising the cost associated with the participation.

# Ruling

25. The match fees and travel allowances paid by the NTFL to umpires officiating in the League are not assessable income under sections 6-5 or 15-2.

26. Losses and outgoings incurred by umpires officiating in the League in connection with their activities as an umpire cannot be claimed as a deduction under section 8-1 or any other provision of the ITAA 1997.

# Appendix 1 – Explanation

• This Appendix is provided as information to help you understand how the Commissioner's view has been reached. It does not form part of the binding public ruling.

27. A payment or other benefit received by a taxpayer is assessable income if it is:

- income in the ordinary sense of the word (ordinary income); or
- an amount or benefit that through the operation of the provisions of the tax law is included in assessable income (statutory income).

### **Ordinary income**

28. Subsection 6-5(1) provides that the assessable income of a taxpayer includes income according to ordinary concepts (ordinary income).

29. The legislation does not provide specific guidance on the meaning of income according to ordinary concepts. However, a substantial body of case law exists which identifies likely characteristics.

30. In *GP International Pipecoaters Pty Ltd v. Federal Commissioner of Taxation*,<sup>1</sup> the Full High Court stated:

To determine whether a receipt is of an income or of a capital nature, various factors may be relevant. Sometimes the character of receipts will be revealed most clearly by their periodicity, regularity or recurrence; sometimes, by the character of a right or thing disposed of in exchange for the receipt; sometimes, by the scope of the transaction, venture or business in or by reason of which money is received and by the recipient's purpose in engaging in the transaction, venture or business.

31. Amounts that are periodical, regular or recurrent, relied upon by the recipient for their regular expenditure and paid to them for that purpose are likely to be ordinary income, as are amounts that are the product in a real sense of any employment of, or services rendered by, the recipient.<sup>2</sup> Amounts paid in substitution for salary or wages foregone or lost may also be ordinary income.<sup>3</sup>

32. Ultimately, whether or not a particular receipt is ordinary income depends on its character in the hands of the recipient.<sup>4</sup> The whole of the circumstances must be considered<sup>5</sup> and the motive of the payer may be relevant to this consideration.<sup>6</sup>

33. Where a taxpayer's activities constitute a pastime or hobby rather than an income producing activity, money and other benefits received from the pursuit of that pastime or hobby will not be included in their assessable income as ordinary income, even if the receipts are regular or periodical.

34. A pastime or hobby can be described as a social or personal pursuit of a non-commercial nature. Amounts received from engaging in a pastime or hobby are generally not intended to, and often do not, cover expenses.

35. The Commissioner accepts that the activities of the umpires who receive payments from the NTFL are a social or personal pursuit of a non-commercial nature and constitute a pastime or hobby, with the payments received being from the pursuit of that pastime or hobby. Consequently, the payments received are not assessable as ordinary income.

36. In forming the opinion that the umpires are engaged in a pastime or hobby, the Commissioner has taken into account the number of matches at which they officiate, the amount and the purpose of the payments they can receive, the factors that can motivate their participation, and the level or division of the sporting competition.

### **Statutory income**

37. Section 6-10 refers to amounts that are not ordinary income. These amounts are called statutory income. A list of the statutory income provisions can be found in section 10-5. The most relevant provision to consider for football umpires is the potential operation of section 15-2.

38. Subsection 15-2(1) states that:

Your assessable income includes the value to you of all allowances, gratuities, compensation, benefits, bonuses and premiums \*provided to you in respect of, or for or in relation directly or indirectly to, any employment of or services rendered by you...

39. Amounts that are a reward or remuneration for services rendered, or a product, incident or consequence of employment, come within the scope of subsection 15-2(1).<sup>7</sup>

40. Umpires covered by this Ruling are not considered to be employees of the NTFL. The payments are considered to be incidental to a pastime or hobby and not a product or incident of any employment or a reward for services rendered by them. As such, the payments are not assessable under section 15-2.

41. As the payments are neither ordinary nor statutory income, they are not assessable income of the umpires who receive them.

### **General deductions**

42. As the payments received by the umpires are not assessable income, all losses and outgoings that are incurred in connection with these activities are not allowable as a deduction under section 8-1. Nor will a deduction be allowable under any other provision of the ITAA 1997.

### Pay As You Go (PAYG) withholding

43. As explained above, payments made to an umpire engaged in a hobby or pastime activity are not assessable income. The payments are not regarded as withholding payments under Division 12 of Schedule 1 to the *Taxation Administration Act 1953*. An entity making payments to umpires who are in the class of entities to which this Ruling applies will not be required to withhold amounts from these payments, nor would they have any other associated PAYG withholding obligations – for example, obtaining Tax File Number declarations, providing payment summaries, or annual reporting.
