## Law Companion Guideline

### Attribution Managed Investment Trusts: dividend, interest and royalty withholding

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It amends Law Companion Guideline LCG 2015/12 to remove references to Law Companion Guideline due to change of name to Law Companion Ruling.

#### LCG 2015/12 is amended as follows:

##### 1. Title (including headers and footers)

Omit 'Law Companion Guideline LCG 2015/12'; substitute 'Law Companion Ruling LCR 2015/12'.

##### 2. Entire document

Omit all occurrences of 'LCG'; substitute 'LCR'.

##### 3. Entire document

Omit all occurrences of 'Guideline'; substitute 'Ruling'.
