Law Companion Guideline

Superannuation reform: concessional contributions – defined benefit interests and constitutionally protected funds

This Addendum is a public ruling for the purposes of the *Taxation Administration Act 1953*. It amends Law Companion Guideline LCG 2016/11 to remove references to Law Companion Guideline due to change of name to Law Companion Ruling.

LCG 2016/11 is amended as follows:

1. Title (including headers and footers)

Omit 'Law Companion Guideline LCG 2016/11'; substitute 'Law Companion Ruling LCR 2016/11'.
