Addendum

Goods and Services Tax Determination

Goods and services tax: is a supply of rights to accommodation a supply of real property for the purposes of the *A New Tax System (Goods and Services Tax) Act 1999*?

This Addendum amends Goods and Services Tax Determination GSTD 2004/3 to reflect:

- the amendments to the A New Tax System (Goods and Services Tax) Act 1999 resulting from the introduction of the Tax Laws Amendment (Small Business) Act 2007. This Act standardises the eligibility criteria for small business tax concessions from 1 July 2007; and
- the amendments to the A New Tax System (Goods and Services Tax) Regulations 1999 resulting from the commencement of the A New Tax System (Goods and Services Tax) Amendment Regulations 2007 (No. 2). This Legislative Instrument changes the threshold amounts for the requirements to register for the GST from 1 July 2007.

GSTD 2004/3 is amended as follows:

1. Paragraph 3

- (a) Omit 'annual turnover'; substitute 'GST turnover'.
- (b) Insert 'turnover' before 'thresholds'.

2. Paragraph 11

- (a) Omit 'current annual turnover'; substitute 'current GST turnover'.
- (b) Omit 'projected annual turnover'; substitute 'projected GST turnover'.

3. Paragraph 12

Omit '\$50,000': substitute '\$75,000'.
