4. Paragraph 25

(a) Insert at the end of the first sentence:

to be conducted on or prior to the Initial Establishment Services Date. The Initial Establishment Services Date is defined in paragraph 25A.

- (b) After the paragraph insert:
 - 25A. The Initial Establishment Services Date is either:
 - (a) 30 June 2006, for those Growers who enter the Project on or before 31 March 2006 ('2006 Planted Growers'); or
 - (b) 30 June 2007 for those Growers who enter the Project after 31 March 2006 and on or before 30 June 2006 ('2007 Planted Growers').

5. Paragraph 26

Before the paragraph insert the heading:

Pooling

6. Paragraph 27

After the paragraph insert:

27A. The 2006 Planted Growers and 2007 Planted Growers are two separate and distinct classes of Growers within the Plantation. The Plantation Land and Plantation Produce for each class will be kept separate.

Omit the paragraph and substitute:

29. A Grower's share of produce will be calculated by reference to the size of the Grower's FRI compared to the overall size of the plantation land of all Growers in their class, that is, 2006 Planted Growers and 2007 Planted Growers respectively (except where the grower is an Affected Grower).

8. Paragraph 67

Omit from the second sentence the words:

these Growers for the income years ending **30 June 2006 to 30 June 2030**

and substitute:

2006 Planted Growers for the income years ending 30 June 2006 to 30 June 2030 and 2007 Planted Growers for the income years ending 30 June 2006 to 30 June 2031.

9. Paragraph 96

Omit '2006'; substitute '2008'.

10. Paragraph 113

Insert the following in the first sentence after '2030':

and 30 June 2006 to 30 June 2031 for the 2006 Planted Growers and the 2007 Planted Growers respectively.

11. Paragraph 113

Insert the following in the second sentence after '2030':

and 30 June 2006 up to and including 30 June 2031 for the 2006 Planted Growers and the 2007 Planted Growers respectively.
