## Superannuation Guarantee Determination

Superannuation guarantee: what is the maximum contribution base for a quarter in the 2005-2006 year?

## Preamble

Superannuation Guarantee Determinations do not have the force of law. Each decision made by the Australian Taxation Office is made on the merits of the individual case having regard to any relevant Rulings and Determinations.

## 1. **\$33,720.**

2. By applying subsection 15(3) of the *Superannuation Guarantee (Administration) Act 1992* (SGAA 1992), the maximum contribution base for a quarter in the 2005-2006 year is:

\$32,180 × Indexation factor for the 2005-2006 year (maximum contribution base for a quarter in 2004-2005)

3. By applying section 9 of the SGAA 1992, the indexation factor for 2005-2006 is the greater of '1' and the number found by dividing the AWOTE amount for February 2005 by the AWOTE amount for February 2004.

4. The AWOTE amount is an estimate by the Australian Statistician of the full-time AWOTE for persons in Australia. The estimate for February 2005 was \$992.90 and the estimate for February 2004 was \$947.80.

5. This produces an indexation factor of 1.048. When applied to \$32,180 the amount comes to \$33,724.64. Subsection 15(4) provides for this amount to be rounded to the nearest 10 dollar multiple (rounding 5 dollars upwards). Therefore, the maximum contribution base for a quarter in the 2005-2006 year is \$33,720.
