Income tax: value of goods taken from stock for private use for the 2014–15 income year

Taxation Determination TD 2015/9 is withdrawn with effect from 11 November 2021.

1. TD 2015/9 provides the amounts that the Commissioner will accept as estimates of the value of goods taken from trading stock for private use by taxpayers in named industries.
2. TD 2015/9 is being withdrawn as its period of effect has passed. The Determination will continue to be legally binding on the Commissioner for the relevant period to which it relates.
