Taxation Ruling TR 95/10 is withdrawn with effect from 19 June 2025.

 - the assessability of allowances and reimbursements received by employee shop assistants
 - deductions for work-related expenses commonly claimed by employee shop assistants.
2. The Ruling is no longer current due to developments in case law and legislation. The Ruling is therefore withdrawn.
