## Taxation Ruling

### Income tax: hospitality industry employees - allowances, reimbursements and work-related deductions

Taxation Ruling TR 95/11 is withdrawn with effect from 19 June 2025.

1. This Ruling provides views on:
  - the assessability of allowances and reimbursements received by hospitality employees
  - deductions for work-related expenses commonly claimed by hospitality employees.
2. The Ruling is no longer current due to developments in case law and legislation. The Ruling is therefore withdrawn.
