Income tax: hospitality industry employees - allowances, reimbursements and work-related deductions

Taxation Ruling TR 95/11 is withdrawn with effect from 19 June 2025.

 - the assessability of allowances and reimbursements received by hospitality employees
 - deductions for work-related expenses commonly claimed by hospitality employees.
