## Taxation Ruling

### Income tax: employee cleaners - allowances, reimbursements and work-related deductions

Taxation Ruling TR 95/8 is withdrawn with effect from 19 June 2025.

1. This Ruling provides views on:
  - the assessability of allowances and reimbursements received by employee cleaners
  - deductions for work-related expenses commonly claimed by employee cleaners.
2. The Ruling is no longer current due to developments in case law and legislation. The Ruling is therefore withdrawn.
