### Income tax: real estate industry employees - allowances, reimbursements and work-related deductions

Taxation Ruling TR 98/6 is withdrawn with effect from 19 June 2025.

- the assessability of allowances and reimbursements received by real estate employees
- deductions for work-related expenses commonly claimed by real estate employees.
