Where the tax-free threshold is claimed and your employee earns:

- more than \$6,550 but less than \$6,922, withhold \$2,080 plus 39.00 cents for each \$1 of earnings in excess of \$6,550
- more than \$6,921, withhold \$2,226 plus 47.00 cents for each \$1 of earnings in excess of \$6,921.

Where the tax-free threshold is not claimed and your employee earns more than \$6,550, withhold \$2,380 plus 47.00 cents for each \$1 of earnings in excess of \$6,550.

For all withholding amounts calculated, round the result to the nearest dollar.
